Each PIU represents a contingent right to receive one (1) unit of limited partnership interest (an "OP Unit") in the Operating Partnership upon vesting and the satisfaction of certain tax-driven economic requirements. OP Units do not expire.
- The PIUs have been earned, but not yet vested, based on Absolute Total Shareholder Return for the 2022-2024 performance period, as certified by the Compensation Committee as of January 10, 2025.
- 25% of the PIUs earned based on the 2022-2024 performance period will vest at the end of each quarter of 2025, subject to continued employment and accelerated vesting upon certain events.
- The PIUs have been earned, but not yet vested, based on Relative Total Shareholder Return for the 2022-2024 performance period, as certified by the Compensation Committee as of January 10, 2025.
